





## DID YOU KNOW?

 During the 1800<sup>s</sup> the City of Boise had a \$5.00 Dog Tax as part of the property taxes.

 In early 1960 the Boise City Council approved the requirement that all dogs within the City limits be licensed.

## Current City Code

**Boise City Code Section 6-7-17 states that it is unlawful for a person to own, harbor, keep or possess an unlicensed dog within the city limits.**

**Annual License Fees**

- \$50.50 . . . . . Non-sterilized Dog (over 1 year old)
- \$26.50 . . . . . Non-sterilized Dog (under 1 year of age)
- \$20.50 . . . . . \*Spayed or Neutered (verification needed)
- \$10.75 . . . . . \*Senior Citizen Discount (Owner over 65 with sterilized dog)

*\*(Must include written proof from veterinarian)*
