SALARIES

Sections:

1-15-01 MAYOR AND COUNCIL; SALARIES

In accordance with Title 50 of Idaho Code, compensation for the Mayor and City Councilmembers shall be fixed by ordinance at least seventy-five (75) days prior to any general city election. Annual salaries are effective January 1 of the following year.

A. The annual salary of the Mayor shall be as follows:

1. The Mayor shall receive an annual salary of one hundred thirty-six thousand, seven hundred and seventy dollars (\$136,770.00), effective January 1, 2018.
2. The Mayor shall receive an annual salary of one hundred forty thousand, eight hundred and seventy-three dollars (\$140,873.00), effective January 1, 2019.
3. The Mayor shall receive an annual salary of one hundred forty-five thousand, ninety-nine dollars (\$145,099.00), effective January 1, 2020.
4. The Mayor shall receive an annual salary of one hundred forty-nine thousand, four hundred and fifty-two dollars (\$149,452.00), effective January 1, 2021.

B. The annual salary of each member of the City Council shall be as follows:

1. Each member of the City Council shall receive an annual salary of twenty-four thousand, nine hundred and thirteen dollars (\$24,913.00), effective January 1, 2018.
2. Each member of the City Council shall receive an annual salary of twenty-five thousand, six hundred sixty dollars (\$25,660.00), effective January 1, 2019.
3. Each member of the City Council shall receive an annual salary of twenty-six thousand, four hundred thirty dollars (\$26,430.00), effective January 1, 2020.
4. Each member of the City Council shall receive an annual salary of twenty-seven thousand, two hundred twenty-three dollars (\$27,223.00), effective January 1, 2021.

C. Whenever any member of the City Council assumes the office of Mayor during the Mayor's absence, that Councilmember shall receive an additional fifty dollars (\$50.00) per day while so acting.

D. The Mayor and each member of City Council shall receive one hundred and fifty dollars (\$150.00) per month to be used for incidental expenses including in-town travel, meetings, and cellular phone use.

E. The Mayor and City Council may receive benefits in accordance with Idaho statute and City policy.
